Staffing Issues:

The Executive Director informed the board the candidate discussed at the last board meeting has reapplied for the position. The board instructed the executive director to reach out to Ms. Slivinksi.

Section 15 proceedings:

Attorney Michael Sacco informed the board he has obtained most of the documentation for both Mr. Pessoa and Mr. Correla. He informed the next issue to be decided by the board would be how to hold the necessary hearing(s) for the two members. Being that both parties are incarcerated it is highly unlikely they could appear before the board in any means other than remote participation. Atty Sacco recommended two general courses of action. One he could conduct the remote hearing at his office in the presence of a court stenographer. The second would be to have a remote hearing at a board meeting with the board present. There was discussion amongst the board as two how to proceed and it was quickly determined that having Attorney Sacco conduct the hearings at his office with a court stenographer would be the most prudent and efficient course of action.
